

AGREEMENT and RELEASE

I/We, as the actual participant and responsible parent/guardian of participant on proposed New Horizon Tours trip, agree to the following:

1. New Horizon Tours is acting in our behalf only in the capacity of an agent for travel arrangements.
2. New Horizon Tours utilizes transportation provided by carriers who are not the employees of New Horizon Tours and I will not hold New Horizon Tours responsible for the default of any such carrier or its personnel. I also agree that I will pay any additional expense incurred due to any delays in service, weather, strike or other causes, which are not the direct fault of New Horizon Tours.
3. I/We understand that New Horizon Tours will immediately upon being informed of any illness or injury to my child make a reasonable effort to advise parent/emergency contact of the nature and extent of such illness or injury. In the event that my child become ill or injured and someone cannot be reached, I hereby authorize a representative of New Horizon Tours to obtain for my child at my expense any and all medical treatment recommended by a physician.
4. I agree that in the event that it is necessary in the opinion of New Horizon Tours to transport my child home on account of illness, injury or misbehavior, I agree to pay for the cost of said transportation.
5. If my child or any of his/her possessions are injured, damaged, or lost due to an accident which occurs while he/she is in a vehicle or airplane hired by New Horizon Tours during the period of this trip, I agree that New Horizon Tours is not responsible for the loss, injury or damage to any of his/her possessions whether said injury, loss or damage occurs as a result of accident or for any other reason while said child is on this NEW HORIZON TOURS tour.
6. In the event that my child behaves in an unbecoming manner in the judgment of a representative of New Horizon Tours, then New Horizon Tours may send my child home at my expense. In that regard, I agree that my child shall not bring with him or purchase wine, beer, or other alcoholic beverage or drugs of any type unless they are prescribed by a physician and are necessary to the health of my child.
7. New Horizon Tours reserves the right to change schedules or cancel any part of this tour due to conflict of dates or unavailability of event at time of booking and may make refunds or compensate participants accordingly.
8. If, for any reason or circumstance beyond the control of New Horizon Tours, it becomes necessary to cancel a trip prior to its departure or during the trip then only unused fees will be refunded. Financial commitments and payments are made weeks and months prior to a trip; therefore, certain fees are used and not refundable to New Horizon Tours. These fees are in the form of transportation, lodging reservations and office services. Refunds will be based on a prorated amount of those fees that are refundable to New Horizon Tours. Refunds are made within 45 days after notice of cancellation.
9. New Horizon Tours reserves the right to refuse or accept or retain any person or member of this tour.
10. I/We hereby release New Horizon Tours, its employees, representatives, and school/district to which my child belongs from any and all liability which may arise as a result of any injury to my child which occurs during this tour.
11. On most tours a tour guide is provided by either the sponsoring group or New Horizon Tours. Tour Guides are available to answer questions, assist with basic problems, injuries & illness and maintain a comfortable and efficient trip. Tour guides do not provide services similar to those provided by parents, guardians, teachers or law enforcement officers. No one should participate on a tour if he/she requires more than minimum supervision.
12. If a tour participant is meeting a NEW HORIZON TOURS tour on site or departing early from the tour, New Horizon Tours is not responsible for supervision of participant once departed from tour group or problems resulting from air travel logistics, including ground transportation to and from airports and lodging facilities.

This agreement is in addition to the above and should not be interpreted in any way to limit the release heretofore agreed to between parent or guardian and New Horizon Tours.

I, _____ (participant's name), do hereby agree to comply with the following policies and procedures on the tour that I am attending and I understand that if I am in violation of these policies and procedures that the listed consequences will take immediate effect:

1. The use of all alcoholic beverages is prohibited at all times if I am a minor.
2. The use of marijuana, narcotics, dangerous and hallucinogenic drugs is prohibited at all times.
3. **Evening curfew must be adhered to at all times.** Leaving your room except in an emergency or to consult a chaperon is a violation.
Violation of the above will result in my losing privileges for the subsequent day at my expense and/or may result in dismissal from the tour as defined in clause (4) below. If a minor, my parents will be notified.
3. All participants are responsible for their luggage, money and any and all personal belongings at all times. New Horizon Tours assumes no responsibility for the theft, loss and/or the loading and unloading of equipment and luggage.
4. All participants are expected to adhere to the policies and procedures set forth by New Horizon Tours. Failure to follow these established policies and procedures will result in a dismissal from tour without notice. Dismissal from tour is defined as forfeiture of remaining night's lodging, food on tour, tour privileges, and transportation without refund. All expenses from time of dismissal shall be assumed by the individual and/or his/her parents or legal guardian.

I have read both sides of this agreement and I agree to all of the terms including but not limited to that portion which limits the responsibility of New Horizon Tours.
